Meeting Summary **Motor Vehicle Dealer Board**

Monday, January 23, 2017

Vice-Chairman Joe Tate called the Dealer Board meeting to order at 9:28 a.m. in Room 702 of the DMV Headquarters Building at 2300 West Broad Street in Richmond. The roll was called and there were 14 Board members present. Present were members Ted Bailey, Dan Banister, Liza Borches, Gardner Britt, David Duncan, Steve Farmer, Robert Fisher, David Gripshover, Clay Huber, Ron Kody, Chris Maher, Geoff Malloy and Jacques Moore. **NOTE:** Gardner Britt and Jacques Moore were absent during the Committees. (Absent: Michael Bor, Rick Holcomb, Matt McQueen, Senior Saghafi and Maurice Slaughter). Executive Director William Childress, Peggy Bailey, Prin Cowan, Lisa Mack-Nelson, Wanda Neely and Ann Majors represented the Dealer Board. Janet Baugh represented the Attorney General's Office. Alice Weedon was the recording secretary.

PUBLIC COMMENT

There was no public comment.

The November 14, 2016 meeting summary was approved.

STATUTORY COMMITTEE REPORTS

Dealer Practices Committee:

Chairman Ron Kody summarized discussions held and actions that were taken during the Committee Meeting.

• Insight Motors, LLC and Issac Abban, Jr. Chairman Kody made the following motion: The Board has reviewed and considered the facts and evidence and the report of an informal fact finding conference as prepared by the hearing officer concerning Insight Motors, LLC and Isaac Abban Jr., for alleged violations of Va. Code section §46.2-1575 (9). The Board mandates that Insight Motors, LLC and Isaac Abban Jr., hereby be assessed a civil penalty of \$250.00 and that Isaac Abban Jr., shall successfully complete the dealer-operator course by July 23, 2017. Successful completion of the dealer-operator class by the mandated July 23, 2017 will reduce the civil penalty assessed by the Board by \$150.00. Failure to successfully complete the dealer-operator course by July 23, 20117 will result in suspension of all licenses and certificates issued by the Board until such time Isaac Abban Jr., successfully comply with the Board's mandates and remit an additional \$150.00 civil penalty for failing to meet all requirements as stipulated on or before July 23, 2017.

Rob Fisher seconded. The motion carried unanimously.

Licensing Committee

Chairman Joe Tate summarized discussions held and actions that were taken during the Committee Meeting.

• Alvin Robinson, Jr., Sales Applicant. Chairman Tate made the following motion: The Board has reviewed and considered the facts and evidence and the report of an informal fact finding conference as prepared by the hearing officer concerning Alvin Robinson for alleged violations of Va. Code section §46.2 - 1575(1). Based on due consideration, the Board mandates that Alvin Robinson hereby be assessed a civil penalty of \$500 and be allowed to apply for a salesperson license.

Chris Maher seconded. The motion carried unanimously.

• **Demetrius D. Watkins, Sales Applicant.** Chris Maher made the following motion: The Board has reviewed and considered the facts and evidence and the report of an informal fact finding conference as prepared by the hearing officer concerning Alvin Robinson for alleged violations of Va. Code section §46.2 -1575(1) and (13). Based on due consideration, the Board mandates that Demetrius Watkins hereby be assessed a civil penalty of \$500 and be allowed to apply for a salesperson license.

Mr. Watkins was present and spoke on his own behalf. (Mr. Watkins was not present during the Licensing Committee).

David Gripshover seconded. The motion carried unanimously.

NOTE: The Licensing Committee voted to deny Mr. Watkins a license; however in giving him the opportunity to speak at Full Board, it was in that conversation the motion changed. The Board requested feedback of Mr. Watkins employment as a salesperson within 90 days.

Advertising Committee

Chairman David Duncan summarized discussions that were held during the Committee Meeting.

• Lustine Toyota and L. N. Kairys and James Giddings. Chairman Duncan made the following motion: The Board has reviewed and considered the facts and evidence and the report of an informal fact-finding conference as prepared by the hearing officer concerning Lustine Toyota, Inc. and L. N. Kairys for alleged violations of Va. Code section §46.2-1575 (1) and (7), and 46.2-1581.12. Based on due consideration, the Board mandates that the Lustine Toyota, Inc. dealership satisfactorily pass an inspection conducted by a Motor Vehicle Dealer Board field inspector on or before July 23, 2017. Failure to pass the inspection on or before July 23, 2017 will result in suspension of all licenses and certificates issued by the Board until such time as Lustine Toyota, Inc., and and L. N. Kairys successfully comply with the Board's mandates.

Steve Farmer seconded. The motion carried unanimously.

Transaction Recovery Fund Committee:

Chairman Chris Maher summarized discussions held and actions that were taken during the Committee Meeting.

Chairman Chris Maher summarized for the Board the discussion held in the committee meeting regarding (1) Jonah Mericle vs. TNT Select Motors and Harlen H. Devold, Jr. and (2) Christine H. Black vs. Thomas Auto Works and Clarence A. Thomas. Based on that discussion and the recommendations in these cases, Mr. Maher made the following motion: Pursuant to VA Code Section 46.2-1527.1 et. seq. of the Code of Virginia, which is known as the Motor Vehicle Transaction Recovery Fund ("Fund"), the Board has reviewed and considered the claims submitted for payment from the Fund and based on due consideration and recommendation of the hearing officer, the Board believes the following claims should be payable from the Fund:

Jonah Mericle vs. TNT Select Motors/Harlen Devold, Jr. \$3,559 Christine H. Black vs. Thomas Auto Works/Clarence Thomas \$9,058

Rob Fisher seconded. The motion carried unanimously.

OLD BUSINESS

Internet Task Force. William Childress indicated that at the November meeting, Chairman Holcomb appointed Mr. Kody and Mr. Tate as Co-chairs for a committee to discuss internet advertising. As of now, including the Vice-Chairs, the committee is comprised of Chris Maher, Clay Huber, Michael Bor, and John Summer (JTZ Enterprises). After the meeting others in attendance volunteered to serve on this committee, they are: Anne Gambardella and Mike Sharapp (VADA), and Pete Iarraci (VIADA). William informed the Board that that the American Association of Motor Vehicle Administrators (AAMVA) was forming a working group to examine internet sales. This working group will look into vehicle advertising and sales electronically, to include the internet. Since AAMVA represents the nation, William has asked AAMVA to allow him to be a part of this working group. Travel expenses will be minimum since most of the work will be accomplished via phone conferences and emails. William's application is being reviewed and he will keep the Board informed regarding this issue. Ron Kody suggested that the task force start the process by having telephone conference call sometime in February, which the Board staff will arrange.

Inclement Weather: William Childress discussed the recently cancelled January 9th Board meeting, which was cancelled due to inclement weather (snow). This was the first time a Board meeting had ever been cancelled. William apologized for this inconvenience, as some Board members had checked into their hotel rooms only to discover shortly afterwards that Richmond area State Agencies were closed on Monday, thus cancelling the meeting. William presented a policy for inclement

weather/emergency closing proposal to the Board for their consideration. With the Board's permission, William sought the authority to cancel a scheduled meeting by noon the Friday prior to the scheduled Board meeting. Cancelling the meeting by noon the Friday before the scheduled Monday meeting will give the Board sufficient time to notify all Board members (email and text message), respondents, the trade associations, the caterer, the Westin Hotel, and DMV (Law Enforcement, the Executive Secretary, and the audio visual staff). The MVDB staff will also post the closing on the Board's web-site. In cancelling the meeting it would automatically push the meeting to the 3rd Monday of that month. By consensus of the Board, the Executive Director was delegated to cancel and reschedule meetings based on the criteria discussed. Some Board members requested to be notified by text message in the event of a cancellation. The Board staff will collect Board member's cell numbers to notify them of a cancellation.

Office and Staff Issues: William indicated that the staff office is going through some cost cutting measures and renovations for the better of the office. These items will be shared in future Board meeting. Also, William announced that Dean Harbour was hired as the field representative in the District 2 area and the applications for the District 6 area have been submitted and interviews will begin January 24.
