Vice-Chairman Ron Kody called the Dealer Board meeting to order at 11:15 a.m. in Room 702 of the DMV Headquarters Building at 2300 West Broad Street in Richmond. The roll was called and there were 13 Board members present. Present were Cody Arnett, Ted Bailey, Dan Banister, Michael Bor, Liza Borches, Gardner Britt, Steve Farmer, David Gripshover, Chris Maher, Senior Saghafi, Maurice Slaughter and Joe Tate. (Absent: Rick Holcomb, David Duncan, Rob Fisher, Randy Harris, Geoff Malloy, Matt McQueen). Executive Director William Childress, Peggy Bailey, Prin Cowan, Lisa Mack-Nelson, Ann Majors and Wanda Neely represented the Dealer Board. Christian Parrish represented the Attorney General's Office. Alice Weedon was the recording secretary.

Before the Full Board addressed the agenda before them, Ron Kody presented Dan Banister with his certificate of appointment and pin. Mr. Banister was appointed to the Board in December 2017. Mr. Banister's appointment is effective until June 30, 2019.

PUBLIC COMMENT

There was no public comment.

The November 13, 2017 meeting summary was approved.

STATUTORY COMMITTEE REPORTS

Dealer Practices Committee:

Committee Chairman Ron Kody summarized discussions held and actions that were taken during the Committee Meeting.

Great Affordable Autos, LLC and Michael J. Mezo – Chris Maher made the following amended motion: The Board has reviewed and considered the facts and evidence and the report of an informal fact finding conference as prepared by the hearing officer concerning Great Affordable Autos LLC and Michael J. Mezo for alleged violations of Va. Code sections §46.2-1533, and 46.2-1575 (2). Based on due consideration, the Board believes that the following actions should be taken against Great Affordable Autos LLC and Michael Mezo: Assessed a civil penalty of \$ 1,000.00 and Great Affordable Autos shall be inspected by a Motor Vehicle Dealer Board field representative by July 8, 2018 and that inspection shall be satisfactory. The Board mandates that Michael J. Mezo hereby be assessed a civil penalty of \$1,000, and the Great Affordable Autos LLC dealership shall satisfactorily pass an inspection conducted by a Motor Vehicle Dealer Board field representative to pass the inspection by July 8, 2018 will result in suspension of all licenses and certificates issued by the Board until such time Great Affordable LLC and Michael J. Mezo complies with the Board's mandates.

Joe Tate seconded. The motion carried unanimously.

NOTE: The original motion was made by Ron Kody to access a civil penalty of \$750 and it was seconded by David Gripshover. After some general discussion, Chris Maher amended the motion to a higher civil penalty.

Hertz Car Sales and Mark Frissora – Committee Chairman Kody made the following motion: The Board has reviewed and considered the facts and evidence and the report of an informal fact finding conference as prepared by the hearing officer concerning Hertz Car Sales and Mark Frissora for alleged violations of Va. Code sections §46.2-1537. Based on due consideration, the Board believes that the following actions should be taken against Hertz Car Sales and Mark Frissora: Assessed a civil penalty of \$ 1,000.00; and the Board mandates that Hertz Car Sales and Mark Frissora hereby be assessed a civil penalty of \$1,000.

Mr. Richard Boblits spoke on behalf of Hertz Car Sales.

Michael Bor seconded. All in favor: 11 (Tate, Arnett, Bailey, Banister, Bor, Borches, Farmer, Gripshover, Maher, Saghafi and Slaughter). Opposed: 2 (Britt and Kody). The motion carried.

Licensing Committee

Committee Chairman Joe Tate summarized discussions held and actions that were taken during the Committee Meeting.

Matthew Sicurella, Sr., Sales Applicant – Committee Tate made the following motion: The Board has reviewed and considered the facts and evidence and the report of an informal fact finding conference as prepared by the hearing officer concerning Matthew S. Sicurella, for alleged violations of Va. Code section §46.2-1575 (13). Based on due consideration, the Board believes; the following actions shall be taken against Matthew S. Sicurella: Denial of Salesperson application. The Board mandates that Matthew S. Sicurella, hereby is denied a salesperson license application.

Chris Maher seconded. The motion carried unanimously.

William M. Edwards, III, Sales Applicant – Committee Chairman Tate made the following motion: The Board has reviewed and considered the facts and evidence and the report of an informal fact finding conference as prepared by the hearing officer concerning William M. Edwards, II, for alleged violations of Va. Code section §46.2-1575 (13). Based on due consideration, the Board believes the following actions shall be taken against William M. Edwards, II; Allowed to apply for a salesperson license. The Board mandates that William M. Edwards, II, hereby is allowed to apply for a salesperson license.

Steve Farmer seconded. The motion carried unanimously.

Matthew R. Bell, Sales Applicant – Committee Chairman Tate made the following motion: The Board has reviewed and considered the facts and evidence and the report

of an informal fact finding conference as prepared by the hearing officer concerning Matthew R. Bell, for alleged violations of Va. Code section §46.2-1575 (13). Based on due consideration, the Board believes the following actions shall be taken against Matthew R. Bell; Denial of Salesperson application. The Board mandates that Matthew R. Bell hereby is denied a salesperson license application until his probation period is completed.

David Gripshover seconded. The motion carried unanimously.

Shawn Lee Dao, Sales Applicant – Committee Chairman Tate made the following motion: The Board has reviewed and considered the facts and evidence and the report of an informal fact finding conference as prepared by the hearing officer concerning Shawn Lee Dao, for alleged violations of Va. Code section §46.2-1575 (13). Based on due consideration, the Board believes the following actions shall be taken against Shawn Lee Dao; Allowed to apply for a salesperson license. Shawn Lee Dao and all future employers shall submit an affidavit to the Board. The Board will approve Shawn Lee Dao's application for a salesperson license and mandates that he and all future employers complete and submit an affidavit to the Board before a license will be issued or transferred.

David Gripshover seconded. The motion carried unanimously.

Advertising Committee

Vice-Committee Ted Bailey summarized discussions held and actions taken during the Committee Meeting.

Motion was made by Ted Bailey that this reconditioning fee (any fee not authorized by §46.2-1581(8)) has to be a part of the purchasing price. If violated, the issue will be handled with priority. Violation will result in a 1st warning, 2nd \$1,000 civil penalty and 3rd bring the dealer before the Board (through normal informal fact-finding conference process). David Gripshover seconded. The motion carried unanimously.

Transaction Recovery Fund Committee:

Committee Chair Chris Maher summarized discussions held and actions that were taken during the Committee Meeting.

Nicole Lawrence-Brown vs. Auto Liberty of Arlington – Committee Chairman Maher summarized for the Board the discussion held in the committee meeting regarding Nicole Lawrence-Brown vs. Auto Liberty of Arlington. Based on that discussion and the recommendations in this case, Committee Chair Maher made the following motion: pursuant to Section §46.2-1527.1 et seq. of the Code of Virginia, which is known as the Motor Vehicle Transaction Recovery Fund ("Fund"), the Board has reviewed and considered claims submitted for payment from the Fund, and the recommendation of the Hearing Officer on the claim. Based on due consideration and recommendation of the Hearing Officer, the Board believes the following claims should be payable from the Fund:

Nicole Lawrence-Brown vs. Auto Liberty of Arlington. \$13,500.00

Steve Farmer seconded. The motion carried unanimously.

Kentory Bromley vs. Premium Auto Collection. - Committee Chairman Maher summarized for the Board the discussion held in the committee meeting regarding Kentory Bromley vs. Premium Auto Collection. Based on that discussion and the recommendations in this case, Committee Chair Maher made the following motion: pursuant to Section §46.2-1527.1 et seq. of the Code of Virginia, which is known as the Motor Vehicle Transaction Recovery Fund ("Fund"), the Board has reviewed and considered claims submitted for payment from the Fund, and the recommendation of the Hearing Officer on the claim. Based on due consideration and recommendation of the Hearing Officer, the Board believes the following claims should be payable from the Fund:

Kentory Bromley vs. Premium Auto Collection \$6,140.00

Dan Banister seconded. The motion carried unanimously.

OLD BUSINESS

JTZ Application – William Childress – John Summer submitted his application to become a dealer operator recertification vendor during the November 2017 Board meeting. The Board tabled approval of JTZ's application pending a review of their application by Board staff. William informed the Board that staff had reviewed JTZ's application and found it to be in accordance with all statutory requirements. William recommended to the Board that they approve JTZ's application to be a dealer operator recertification vendor.

Motion was made by Gardner Britt for JTZ to become a Dealer Operator Recertification Testing vendor. Joe Tate seconded. The motion carried unanimously.

William Childress updated the Board regarding the 4 advertising guidelines that were discussed during the November 2017 Board meeting. Those guidelines have sense been reviewed and tweaked by Christian Parrish (AG's Office) and need to be approved by the Board. During the November 2017 Board meeting, the acceptance of the 4 guidelines was not properly seconded, therefore requiring the Board to act on this matter.

Advertising Guidelines:

- 1. Freight Charges
- 2. Transfer Fees

- 3. Advertising Vehicle Location
- 4. Removal of Inventory from Dealer's Website

Motion was made by Joe Tate to approve the advertising guidelines. Steve Farmer seconded. The motion carried unanimously.

Counterfeit Checks – Robert Stone – Special Agent Robert Stone, DMV Law Enforcement Division briefed the Board on a sophisticated cashier's check scam that operated in approximately 13 states across the country, from Washington to Virginia. This scam robbed dealers of new and used vehicles and in some cases, involved unsuspecting innocent bystanders who were paid a fee to assist the scammers in titling the vehicles. The scammers were captured and this matter is going through the legal process.

EXECUTIVE DIRECTOR'S REPORT: William Childress

Motion was made by David Gripshover to grant a license with the stipulation that his employer notify the Board when he leaves or is terminated. Senior Sagahfi seconded. All in favor: 5 (Tate, Banister, Borches, Gripshover, Saghafi). Opposed: 2 (Bailey and Slaughter). The motion carried.

William further explained that Virginia law requires that the advertised price includes all cost/fee with the exception of the processing fees, DMV fees, and freight/shipping charges. However, if the advertise price excludes the processing fees and freight/shipping charges, those fees must be disclosed in the ad. William added that administrative actions were being taken against the violators in accordance to the Board's established processes.

The committee engaged in a spirited and robust discussion regarding this matter that included participation from the VADA representatives and other non-committee Board members. At the heart of the conversation was the need to take swifter and harder actions against violators of this deceptive practice. Motion was made by Ron Kody, that when dealers advertising a Reconditioning Fee, the process is 1st a written warning, 2nd \$1,000 civil penalty and 3rd, bring the dealer before the Board. Michael Bor seconded. The motion carried unanimously. It was also clarified that if you advertise this fee and you sell multiple vehicles with this fee, each vehicle sold with this fee is a separate violation, and subject to appear before the Dealer Practices committee for each vehicle sold, and before the Advertising committee for the deceptive and misleading advertisement.

Kentory Bromley vs. Premium Auto Collection - On December 27, 2017, an informal fact-finding conference was conducted to address the alleged violation of VA Code Section 46.2-1527.3 against Premium Auto Collection. Based on the

information provided at the conference, the hearing officer recommended that the Board pay \$6,140 to Ms. Bromley from the Transaction Recovery Fund. It was also recommended that Premium Auto Collection should have an inspection as soon as practical, with attention to records, titles and documents.

Lee Arzt, Esquire, attorney for Mr. Cleveland Senn (co-owner of Premium Auto Collection at the time of the sale of the vehicle to Ms. Bromley), spoke on behalf of his client.

Johnathan Wright, part of owner of Premium Auto Collection, was present and spoke on his own behalf.

Motion was made by David Gripshover to accept the hearing officer's recommendation that the Board pay \$6,140 to Ms. Bromley. Michael Bor seconded. The motion carried unanimously.
