**STATUTORY COMMITTEE REPORTS**

**Dealer Practices Committee**

Committee Chairman Kody summarized discussions held and actions taken during the Committee Meeting.

**Review and Action: Informal Fact-Finding Conferences**

**DLM Auto, Inc. and Darian J. Hunter.** Ron Kody made the following motion: The Board has reviewed and considered the facts and evidence and the report of an informal fact finding conference as prepared by the hearing officer concerning DLM Auto and Darian Hunter for alleged violations of Va. Code sections §46.2-1529, 46.2-1542 (B), 46.2-1559 and 46.2-1575 (6). Based on due consideration, the Board believes that the following actions should be taken against DLM Auto and Darian Hunter: Assessed a civil penalty of \$234,650.00; and Suspend all licenses and certificates issued by the Board to Darian Hunter until the Department of Motor Vehicles' Law Enforcement Division conducts an investigation into DLM Auto and provides a report from that investigation to the Motor Vehicle Dealer Board during a regularly scheduled meeting. The Board mandates that Darian Hunter hereby be assessed a civil penalty of \$234,650.00, and all licenses and certificates issued to Darian Hunter are suspended until the Board has been provided and reviewed a report submitted by the Department of Motor Vehicles' Law Enforcement Division during a future meeting. Failure to comply with the Board's mandates by the required dates will result in the suspension of all licenses, certificates issued by the Board until such time the DLM Auto dealership and Darian Hunter successfully complies with the Board's mandates.

Mr. Darian Hunter was present for the Full Board portion of the meeting and spoke for his dealership.

Christian Parrish introduced himself to Mr. Hunter as counsel for the Motor Vehicle Dealer Board and informed Mr. Hunter that he (Mr. Parrish) cannot advise Mr. Hunter. Mr. Parrish did inform Mr. Hunter that he had every right to have counsel and wanted Mr. Hunter to be aware of his rights. Mr. Holcomb indicated that, due to this matter, there will be no questions posed by the members.

Mr. Hunter informed the Board that he takes full responsibility for the actions of his dealership and his only request is that he is allowed to keep his license. He wants the opportunity to pay that money back. There were no questions of the members.

Chris Maher seconded. The motion carried unanimously.

**Dealer Portal Update** - William Childress updated the Board of the staff's progress with the dealer portal since the September meeting. He informed the Board that the staff was working with VITA and had a signed contract with the vendor on October 23, 2021. A copy of the projected fees and system deliverables were presented to the all Board members. The contract is still going through VITA's approval processes. An update will be provided to the Board at the January 2022 Board meeting.

**Millennial Automotive, LLC and Kayana Murray** – Barbara Arkwright (DMV Law Enforcement) updated the Board regarding Millennial Automotive and Kayana Murray. During the September 2021 Board meeting, the Board requested a DMV Law Enforcement investigation of the Millennial Dealership and Kayana Murray. Agent Arkwright informed the Board that a search warrant of the Millennial Automotive dealership was executed and the dealership's computer was confiscated. The computer is in the custody of the Virginia State Police undergoing a forensic investigation. DMV Law Enforcement is awaiting the results of the State Police investigation.
