Carpro Auto Sales and Redouane Aissi #50736. On August 12, 2025 an informal fact-finding conference was conducted to address the alleged violations of VA Code Sections 46.2-1529 and 46.2-1548. Based on the information provided at the conference, the hearing officer recommended assessing a civil penalty of \$1,250.00 (\$500 for violations of 46.2-1529 and \$750 for violations of 46.2-1548, inspection within 45 days and to successfully complete the 2-day Dealer-Operator course within 90 days.

Redouane Aissi was present and spoke on his own behalf.

Chris Maher moved to accept the hearing officer's recommendation. Don Sullivan seconded. The motion carried unanimously.

Potomac West Motors, LLC and Asif Mahmood #53180. On August 22, 2025, an informal fact-finding conference was conducted to address the alleged violations of VA Code Sections 46.2-1533 and 46.2-1575 (2). Based on the information provided at the conference, the hearing officer recommended to assess a civil penalty of \$250.00 for violations of 46.2-1533.

STATUTORY COMMITTEE REPORTS

Dealer Practices Committee

Committee Chair Andrew Wiley summarized discussions held and actions taken during the Committee Meeting.

Review and Action: Informal Fact-Finding Conferences:

Carpro Auto Sales and Redouane Aissi #50736. Committee Chair Andrew Wiley presented the following motion: Don Sullivan moved that the Board has reviewed and considered the facts, evidence and the report of an informal fact-finding conference as prepared by the hearing officer concerning Carpro Auto Sales and Redouane Aissi for the alleged violations. Based on due consideration, the Board believes the following actions should be taken against Carpro Auto Sales and Redouane Aissi: Assessed a civil penalty of \$1,250.00; and A follow up inspection by a Motor Vehicle Dealer Board field representative within 45 days and that inspection shall be satisfactory. Successful completion of the 2-day dealer-operator course within 90 days. The Board hereby mandates that Carpro Auto Sales and Redouane Aissi shall be assessed a civil penalty of \$1,250.00 due on or before October 14, 2025, Carpro Auto Sales shall undergo an inspection by a Motor Vehicle Dealer Board field representative and the inspection must be satisfactory on or before October 27, 2025, and Redouane Aissi shall successfully complete the 2-day dealer-operator course on or before December 10, 2025. Failure to comply with the Board's mandates by the required dates will result in the suspension of all licenses and certificates issued by the Board until such time Carpro Auto Sales and Redouane Aissi successfully complies with the Board's mandates.

NOTE: During Full Board, they agreed to extend the deadline regarding the Dealer-Operator course from 30 days to 90 days and the resolution reflects the change.

Jeff Ryer seconded. All in Favor: 6 (Dunn, Maher, Reynolds, Ryer, Wiley, Lackey). Opposed: 4 (Bates, Maulbeck, Myers, Sullivan). The motion carried.

Potomac West Motors, LLC and Asif Mahmood #53180. Committee Chair Andrew Wiley presented the following motion: Tom Bates moved that the Board has reviewed and considered the facts, evidence and the report of an informal fact-finding conference as prepared by the hearing officer concerning Potomac West Motors, LLC and Asif Mahmood for the alleged violations. Based on due consideration, the Board believes the following actions should be taken against Potomac West Motors, LLC and Asif Mahmood; Assessed a civil penalty of \$250.00. The Board mandates that Potomac West Motors, LLC and Asif Mahmood shall be assessed a civil penalty of \$250.00 due on or before October 14, 2025. Failure to comply with the Board's mandates by the required dates will result in the suspension of all licenses and certificates issued by the Board until such time Potomac West Motors, LLC and Asif Mahmood successfully complies with the Board's mandates.

Dick Myer seconded. The motion carried unanimously.

Review and Action: Informal Fact-Finding Conferences:

Adrian/Kylie/Shifflett vs. Nobel Motors, LLC. Committee Chair Chris Maher presented the following motion: Pursuant to Section §46.2-1527.1 et seq. of the Code of Virginia, which is known as the Motor Vehicle Transaction Recovery Fund (Fund), the Board has reviewed and considered a claim for payment from the Fund, and the recommendations of the Hearing Officer on the claim. Based on due consideration and the recommendation of the Hearing Officer, the Board approves and acknowledges that the applicant's claim of \$13,207.54 should be payable from the Fund. The Board hereby approves and reaffirms the claim for payment from the Fund.

Andrew Wiley moved to accept the hearing officer's recommendation. M'Lissa Dunn seconded. The motion carried unanimously.

Lawrence T. Hudson, Jr. and Autoline of VA, Inc. Committee Chair Chris Maher presented the following motion: Pursuant to Section §46.2-1527.1 et seq. of the Code of Virginia, which is known as the Motor Vehicle Transaction Recovery Fund (Fund), the Board has reviewed and considered a claim for payment from the Fund, and the recommendations of the Hearing Officer on the claim. Based on due consideration and the recommendation of the Hearing Officer, the Board approves and acknowledges that the applicant's claim of \$25,000.00 should be payable from the Fund. The Board hereby approves and reaffirms the claim for payment from the Fund.

Mr. Hudson was present and just wanted to thank the committee and Micah Bailey for all the assistance he received during this process.

Andrew Wiley moved to accept the hearing officer's recommendation. Tom Bates seconded. The motion carried unanimously.

The Attorney General's review found no legal issues with the approval. However, during the appeal period after the Board's decision, Mr. Wilson requested a formal hearing. As a result, payment to Pamela McZeal is being withheld pending the Board's review of the findings and recommendations from that hearing.

Edward Maulbeck – Advertising issue. Mr. Maulbeck indicated that he has seen dealers advertise a \$899 set up fee. He said that is not a fee, it is fraud. He was questioned as to if it was ever reported and he said he didn't know. Chairman Lackey asked if it was brought to MVDB and he said no. He was questioned as to why it hasn't been brought up to the board earlier. He indicated he was bringing it up during this meeting. Chairman Lackey indicated that it would be addressed, and specifics will be looked at.

UPDATE: Executive Director Applications. Chairman Lackey indicated they received just under 30 applications, and some really good applications were in the mix. He feels confident that an Executive Director will be in place before the end of the year.
